A. CLOSED SESSION

Gm Razzeca also noted that the Notice of Completion would not be filed and that the contract retention amount would not be paid until after the final inspection had been satisfactorily completed.

Board action A motion was made by Commissioner Ferrante, seconded by Commissioner Goulart to authorize the General Manager to enter into an agreement/task order with Sealaska for management of the Cal OES/FEMA aspect of the 2019 Dredge Project, and to authorize the General Manager to enter into an agreement/task order with Sealaska for beach replenishment professional services as needed related to the 2019 Dredge Project. All agreements, or a single master agreement with task orders, will be subject to prior approval of District Counsel and the General Manager and will be in total combined amount not to exceed \$37,000. The motion passed unanimously on a roll-call vote.
